



## **REVIEW OF OPERATIONS JUNE 2013 QUARTER**

During the last quarter ended 30 June 2013 Argosy commenced work on the Graphite Project in Namibia, as announced on 30 April 2013.

Argosy employed Namib Hydrosearch to obtain satellite imagery and interpret the imagery using the Aster system.

On 1 July 2013 Argosy entered into a Pre Bid Implementation Agreement with Baru Resources Limited where by Baru Resources Ltd agreed to make a takeover of Argosy on a share for share basis. The Companies are currently drafting their respective Bidder and Target Statements.

The takeover by Baru will enable Argosy shareholders to receive 1 Baru share for 1 Argosy share held. Baru's cash holdings of approximately \$3m will be available to further progress the Namibian graphite project.
